### Directions For Use

For best results, add **Shake Down** to solution prior to foaming. If foam already exists, add Shake Down until foam is eliminated.

**Shake Down** is a Polydimethylsiloxane approved for use as a spray adjuvant under 40 CFR 180.1001 (c) at labeled rates.

**RATE:** 1/2-1 ounce **Shake Down** per 100 gallons (15-30 milliliters per 378 liters) of solution.

### Storage and Disposal

**Storage:** Segregate from foods and animal feeds. Keep away from heat. Protect from direct sunlight.

**Waste Disposal of Substance:** Must be disposed of or incinerated in accordance with local regulations.

**Container Disposal: DO NOT** reuse or refill this container. **Triple rinse as follows:** Fill container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration. Do not burn, unless allowed by state and local ordinances.

**Accidental Release Measures:** Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. For small amounts: Contain with dust binding material and dispose of. For large amounts: Sweep/shovel up. Dispose of absorbed material in accordance with regulations. Collect waste in suitable containers, which can be labeled and sealed.
